AMENDED RESOLUTION CREATING THE LOVELOCK VALLEY WEED CONTROL DISTRICT

No. 22-04-04

WHEREAS, on January 5, 1970, after proper notice and public hearing, the Board of County Commissioners resolved to create the Lovelock Valley Weed Control District (the "District"); and

WHEREAS, by resolution, the District comprised all public and private lands classified by the County Assessor as cultivated, wild hay, meadow, pasture, and grazing (i.e., Agricultural Lands), within the Pershing County Water Conservation District and other areas of the County; and

WHEREAS, the many parcels within the District previously classified as Agricultural by the County Assessor are now classified residential, which would remove those parcels from the District; and

WHEREAS, removal or these parcels will significantly reduce the District's funding and curtail its ability to eradicate noxious weeds in the Lovelock Valley; and

WHEREAS, the Board of County Commissioners desires to maintain the original boundaries of the District and retain within the District those parcels previously classified as Agricultural.

NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:

 The Lovelock Valley Weed Control District shall continue to exist as established on January 5, 1970, subject to the exclusion of the following lands:

Section 25, Township 25 North, Range 30 East.

EXHIBIT ONE

BOUNDARIES OF LOVELOCK VALLEY WEED CONTROL DISTRICT

The Lovelock Valley Weed Control District shall comprise the public and private lands within the following described area of Pershing County:

- A. All land within the boundaries of the Pershing County Water Conservation District, and
- B. The following parcels:
 - 1. An area 100 feet in width along all ditches, laterals, drainage courses outside the boundaries of the above-mentioned district, south of Rye Patch Dam, using for its center line the center line of such ditch, lateral, or drainage course.*
 - An area 200 feet in width along the Humboldt River from Rye Patch dam to the intersection of the Pershing County Water Conservation District boundary, using for its centerline line the center line of the Humboldt River.
 - ***Exempt from acreage assessment, weed control on these corridors will be financed from the assessment monies collected from the remainder of the District.
 - 3. E ½ E ½ E ½ Section 12, T. 25 N., R. 30 E.
 - 4. All of Section 13, T. 25 N., R. 30 E.
 - 5. Section 20, T. 25 N., R. 31 E.
 - 6. Section 36, T. 26 N., R. 31 E.
 - 7. The land lying between Pershing County Water Conservation District boundary and 100 feet east of the center line of the Humboldt River within Sections 1, 2, 10, 11, 16, and 21, T. 25 N., R. 31 E; Section 6, T. 25 N., R 32 E.; Section 6, 29, 30 and 31, T. 26 N., R. 32 E; Section 24 and 25, T. 27 N., R. 31 E.; and Sections 6, 7, 18 and 19, T. 27 N., R. 32 E.
 - 8. E ½ NE ¼ Section 22, T. 27 N., R. 31 E.

- S ½ NW ¼ Section 13, T. 27 N., R. 31 E; all the portion E ½ SW ¼ lying N of Central Pacific right of way less 3 acres more or less lying between the railroad tracks and the Irish American Ditch.
- 10. All the portion of the SE ¼ lying E of the Humboldt River in Section 6, T. 27., R. 32 E; all that portion W ½ NW ¼ lying N of Highway 40 in Section 8, T. 27 N., R. 32 E; all that portion of the NE ¼ lying E of the Humboldt River and N of Highway 40 in Section 7, T. 27 N., R. 32 E.
- 11. Within Section 24, T. 25 N., R. 30 E., a buffer zone 500 feet in width parallel to the south boundary of Section 13, T. 25 N., R. 30 E., and the west boundary of Section 19, T. 25 N., R. 30 E. Also an identical buffer zone within Section 29 parallel to the east boundary of Section 30, T. 25 N., R. 31 E. from the northwest corner of Section 29 south along section line to the intersection of river channel, and the entire south boundary of Section 20, T. 25 N., R. 31 E. Likewise an identical buffer zone in Section 15, T. 25 N., R. 31 E., parallel to the east boundary of Section 16, T. 25 N., R 31 E., and the south boundary of Section 10, T. 25 N., R. 31 E., from the northeast section corner of Section 15 east of intersection of section line with river channel.

Section 15, Township 25 North, Range 31 East except for a strip five hundred (500) feet on the West and North boundaries of said section and except for an area two hundred (200) feet in width along the Humboldt River using for its center line the center line of the Humboldt River, and except for an area one hundred (100) feet in width along all ditches, laterals, drainage courses within said section lying and being North and West of the Humboldt River.
- 2. Those currently serving on the Board of the Lovelock Valley Weed Control District shall continue to serve as designated in the District's formation resolution of January 5, 1970 and the District's bylaws.
- 3. The Lovelock Valley Weed Control District Shall comprise all private and public lands as set forth in Exhibit One and Exhibit Two, attached hereto and incorporated by reference.
